

Disposal of complaints by the Commission during the month of May' 2007.

In April 2004, the **Govt. of India** had designated the **Central Vigilance Commission** as an agency to receive written complaints or disclosure on any allegation of corruption or of misuse of office by any employee of the Government under **Govt. of India Resolution on Public Interest Disclosures & Protection of Informer**. On receiving such complaints, the Commission forwards them to the concerned departments for investigation and report without disclosing the identity of the complainant. Accordingly, during May' 2007 **the Commission had forwarded 07 such complaints for a report to the respective organisations. 09 complaints have been filed** being petty/anonymous/pseudonymous, 14 complaints have been sent for necessary action. Upto May'2007, 29 complaints have been sent for investigation and report, 66 complaints have been sent for necessary action and 32 have been filed. Departmental action has been advised in 55 cases.

Apart from the complaints received under Govt. of India Resolution on Public Interest Disclosures & Protection of Informer, during May'2007, the Commission had forwarded 44 **complaints** having verifiable and documentary evidences **for investigation and report** to the departments/organizations concerned. The Commission also forwarded **587 complaints** which were either administrative in nature or having no vigilance angle for **necessary action/disposal** to the departments/organisations. **Besides, 346 complaints** which have been found either petty in nature or, anonymous/pseudonymous **have been filed. Upto May'2007, 293 complaints** have been sent for **investigation and report, 2530** have been sent for **necessary action** and 1725 **have been filed**. Commission has advised departmental action in 33 cases.
