

Performance during May, 2018

- (i) Prosecution sanctions were issued by the Competent Authorities in respect of **7** officials of various Ministries/Departments/Organizations.
- (ii) Commission advised initiation of major penalty proceedings against **82** officials of various Ministries/Departments/Organizations.
- (iii) Commission advised imposition of major penalty against **9** officials of various Ministries/Departments/Organization.
- (iv) On the advice of the Commission, the Competent Authorities imposed major penalties in respect of **150** officials of various Ministries/Departments/ Organizations.
- (v) Commission processed **3049** complaints (including **6** whistle blower complaints) during the month and sought investigation report in **18** complaints from the concerned Ministries/Departments/Organizations.
- (vi) Intensive Examination of **03** works carried out by Chief Technical Examiner's Organization resulted in recoveries to the tune of **Rs.1126.42 lakhs** during **May, 2018**.
- (vii) Commission provided inputs in respect of **54** cases for vigilance clearance of officials for Board level appointments in CPSE's. In addition, references of **367** officials of All India Services and Central Services were considered for vigilance clearance in matters of empanelment, promotion etc. and inputs provided by the Commission.
- (viii) **16** officers were considered for appointment/empanelment/extension as full time/part time CVOs in various organizations and recommendations were given by the Commission.

Important activities:

- (i) The Central Vigilance Commission's monthly lecture was delivered by Dr. Ashima Goyal, Member of Prime Minister's Economic Advisory Council on the topic "**Indian Institutions-Evolution and Hysteresis**" on 28th May, 2018.
- (ii) The Commission convened Annual Sectoral Review Meetings-2018 with the Chief Executives/CMDs & Chief Vigilance Officers of **M/o Defence, D/o Defence Production & Border Roads Organisation** on 21/05/2018, **M/o Housing & Urban Development, CPWD & DDA** on 25/05/2018 and **Govt. of NCT of Delhi, North MCD, South MCD & East MCD** on 30/05/2018. During the meetings, Commission emphasized various aspects of vigilance administration, the need for bringing greater transparency and accountability in the functioning and for undertaking systemic improvements, leveraging of technology through e-procurement etc. The Commission also underscored the need for updation of Manuals, sensitization of officials by conducting training programmes, effecting rotational transfer of officials, as well as expeditious finalization of departmental proceedings. Further, analysis of audit reports by the CVO's and the outcome thereof, matters pertaining to pendency of complaints/cases, delay in processing of vigilance cases and cases pertaining to sanction of prosecution were also reviewed by the Commission in the review meetings.
