Performance during September, 2015

- (i) Commission advised issuance of sanction for prosecution in respect of **5** officials of various Ministries/Departments/Organizations.
- (ii) Prosecution sanctions were issued by the Competent Authorities in respect of **14** officials of various Ministries/Departments/Organizations.
- (iii) Commission advised initiation of major penalty proceedings against **76** officials of various Ministries/Departments/Organizations.
- (iv) Commission advised imposition of major penalty against 7 officials of various Ministries/Departments/Organization.
- (v) On the advice of the Commission, the Competent Authorities imposed major penalties in respect of **307** officials of various Ministries/Departments/ Organizations.
- (vi) Commission processed **3022** complaints (including **47** whistle blower complaints) during the month and sought investigation report in **32** complaints from the concerned Ministries/Departments/Organizations.
- (vii) Intensive Examination of **4** works carried out by Chief Technical Examiner's Organization resulted in recoveries to the tune of ₹ **26.35 lakhs** during September, 2015.
- (viii) Commission provided inputs in respect of **29** cases for vigilance clearance of officials for Board level appointments in CPSE's. In addition, references of **206** officials of All India Services and Central Services were considered for vigilance clearance in matters of empanelment, promotion etc. and inputs provided by the Commission.
- (ix) **29** officers were considered for appointment/empanelment as full time/part time CVOs in various organizations and recommendations were given by the Commission.

Important activities:

(i) The Commission convened Annual Sectoral Review Meetings with the Chief Vigilance Officers of Social Sector on 02.09.2015 at CVC, New Delhi, Banking & Insurance Sector-I on 10/09/2015 & Petroleum Sector on 11/09/2015 at Mumbai, Port & Shipping Sector on 18/09/2015 and Banking & Insurance Sector-II at CVC, New Delhi. During the meeting, Commission emphasized various aspects of vigilance administration, the need for bringing greater transparency and accountability in the functioning and for undertaking systemic improvements, leveraging of technology through e-procurement etc. The Commission also underscored the need for updation of Manuals, sensitization of officials by conducting training programmes, effecting rotational transfer of officials, as well as expeditious finalization of departmental proceedings etc. Pendency with the CVOs was also reviewed by the Commission during the meeting.

(ii) Shri K.V. Chowdary, CVC attended 7th Anniversary celebration of the Vigilance Study Circle (Bengaluru Chapter) on 29th September, 2015 at Bangaluru. While addressing the gathering from various Public sector enterprises and Banking sector, he stated that Central Vigilance Commission has set up a committee to streamline cases to be fast tracked. The newly-formed committee will decide on cases that need to be fast tracked based on specific criteria. The Central Vigilance Commission plans to identify and classify misconduct in public sector establishments and other government agencies as serious and fraudulent.
