

Performance during September, 2017

- (i) Commission advised issuance of sanction for prosecution in respect of **4** officials of various Ministries/Departments/Organizations.
- (ii) Prosecution sanctions were issued by the Competent Authorities in respect of **8** officials of various Ministries/Departments/Organizations.
- (iii) Commission advised initiation of major penalty proceedings against **66** officials of various Ministries/Departments/Organizations.
- (iv) Commission advised imposition of major penalty against **3** officials of various Ministries/Departments/Organizations.
- (v) On the advice of the Commission, the Competent Authorities imposed major penalties in respect of **89** officials of various Ministries/Departments/ Organizations.
- (vi) Intensive Examination of **08** work carried out by Chief Technical Examiner's Organization resulted in recoveries to the tune of Rs. **1096.28 lakh** during **September, 2017**.
- (vii) Commission provided inputs in respect of **16** cases for vigilance clearance of officials for Board level appointments in CPSE's. In addition, references of **145** officials of All India Services and Central Services were considered for vigilance clearance in matters of empanelment, promotion etc. and inputs provided by the Commission.
- (viii) **11** officers were considered for appointment/empanelment as full time/part time CVOs in various organizations and recommendations were given by the Commission.
- (ix) Commission processed **2016** complaints (including **53** whistle blower complaints) during the month and sought investigation report in **28** complaints from the concerned Ministries/Departments/Organizations.

Important activities:

- (i) The Union Minister of State of the Ministry of Personnel, Public Grievances & Pensions Dr. Jitendra Singh released the 7th edition of the Vigilance Manual of Central Vigilance Commission on 7th September, 2017.
- (ii) The Commission convened Annual Sectoral Review Meetings with the Chief Vigilance Officers of **Financial Sector** on 07/09/2017, **Banking and Insurance Sector** on 08/09/2017, **Post, Aviation and Transport Sector** on 14/09/2017 and **Other Ministries/Departments/Organizations (i.e, MEA, MHA, DoPT etc.)** on 15/09/2017. During the meetings, Commission emphasized various aspects of vigilance administration, the need for bringing greater transparency and accountability in the functioning and for undertaking systemic improvements, leveraging of technology through e-procurement etc. The Commission also underscored the need for updation of Manuals, sensitization of officials by conducting training programmes, effecting rotational transfer of officials, as well as expeditious finalization of departmental proceedings. Further, analysis of audit reports by the CVO's and the outcome thereof, matters pertaining to pendency of complaints/cases,

delay in processing of vigilance cases and cases pertaining to sanction of prosecution were also reviewed by the Commission in the review meetings.

- (iii) A delegation of Indonesia Corruption Eradication Commission visited Central Vigilance Commission on 14th September, 2017.
- (iv) The Central Vigilance Commission's monthly lecture was delivered by Justice m.M. Kumar, President, NCLT on 21st September, 2017 on the topic "Rule of Law: Achievements and its Trivialization."
